INTENDED TREE WORK INCLUDES:

TG1 BIRCH - REMOVE

THE TREE WORKS ARE PROPOSED TO STOP THE INFLUENCE OF THE TREE(S) ON THE SOIL BELOW BUILDING FOUNDATION LEVEL AND PROVIDE LONG TERM STABILITY AT THE ADDRESS OF 28 WEST END, BUGBROOKE, NORTHAMPTON, NN7 3PF.

Further to receipt of an application for works to trees within a Conservation Area, as a courtesy, we wish to inform you that the Local Planning Authority (LPA) has recently received an application to undertake works to trees from the owner, occupiers or representatives of the above property.

In processing conservation area tree work notifications the Council's Arboricultural Officer visits each site to assess the intended tree work. If this tree work is considered detrimental to public amenity, the tree is then assessed for possible inclusion within a Tree Preservation Order (TPO).

Should the tree not be eligible for inclusion within a TPO then the LPA has no further recourse, and the works may proceed. A copy of the decision notice will be sent to you.

The Council cannot refuse or apply conditions to this proposal as it merely constitutes a notification to carry out works to a tree in a Conservation Area. In the event that the Council considers the proposal to be unacceptable, the only course of action available is to protect the tree with a Tree Preservation Order

This will also tell you the current status of the application together with other useful information, including the reason for this consultation (on the 'Consultee' tab under the 'Constraints List').

If you do not have access to the website you may inspect the application, the plans and other documents submitted with it (including the Environmental Statement) at this office at any time between 8:45 a.m. and 5:15 p.m. Monday to Thursday and up to 4:45 p.m. on Friday. Any member of staff will be able to assist you with general information regarding the application; if you wish to speak to the Case Officer you should make an appointment before visiting the office. The information will be available for inspection for at least 21 days from the date of this letter.
